



Motion to confirm an ARLE Grant municipal match of 31% totaling \$31,400 for the installation of pedestrian crossing signals at the Fifth Avenue and Pine Street intersection. **Moved** by Ms. Leiendecker and seconded by Ms. Drobnick. **Motion carried 5-0.**

Voting delegates were requested for the 2024 Pennsylvania State Association of Boroughs (PSAB) Annual Conference. Mr. Lineaweaver noted that Ms. Drobnick and himself are the only two present this evening that would be attending the conference. Ms. Drobnick nominated Mr. Lineaweaver as a voting delegate and Ms. Drobnick was nominated as an alternate.

Motion to appoint Ryan Lineaweaver as the 2024 PSAB Voting Delegate and Denise Drobnick as the Alternate Voting Delegate. **Moved** by Ms. Bower and seconded by Ms. Leiendecker. **Motion carried 5-0.**

Mr. Sichler shared that a former lifeguard is being interviewed to fill the position of Pool Manager.

Motion to approve the hiring of Alexendra Beighley as Pool Manager at a rate of \$16 per hour. **Moved** by Mr. Wert and seconded by Ms. Bower. **Motion carried 5-0.**

Mr. Sichler shared the Recreation Director's recommendation to onboard the previous Pool Manager to train both the Pool and Assistant Pool Managers to ensure a smooth transition of a new management team. Ms. Drobnick noted that pool staff wages were under budget last year, and the Assistant Manager and Head Lifeguard could be a part of this training for future staffing purposes.

Motion to approve the hiring of Giovanni Estronza as Pool Manager Consultant at a rate of \$16.50 per hour for a maximum of 40 hours. **Moved** by Ms. Leiendecker and seconded by Ms. Drobnick. **Motion carried 5-0.**

Motion to approve the Borough Manager's report. **Moved** by Ms. Drobnick and seconded by Mr. Wert. **Motion carried 5-0.**
