

ORDINANCE NO. 1208

AN ORDINANCE OF WEST READING BOROUGH, BERKS COUNTY, PENNSYLVANIA AMENDING CHAPTER 430, TITLED "VEHICLES AND TRAFFIC, OF ARTICLE III, TITLED "PARKING REGULATIONS," OF SECTION 430-21, TITLED "PARKING PROHIBITED AT ALL TIMES," TO PROVIDE ADDITIONAL PARKING ON THE 100 BLOCK OF NORTH SEVENTH AVENUE, AND THE 200 BLOCK OF SOUTH SIXTH AVENUE, SECTION 430-24, TITLED "TIME LIMIT PARKING", TO DESIGNATE THREE HOUR PARKING TO THE 200 BLOCK OF SOUTH SIXTH AVENUE, AND SECTION 430-26, TITLED "SPECIAL PURPOSE PARKING ZONES" TO REMOVE PATIENT LOADING ZONES ON THE 200 BLOCK OF SOUTH SIXTH AVENUE, AND ADD A HANDICAPPED PERSON PARKING SPACE IN THE 300 BLOCK OF SOUTH THIRD AVENUE.

BE IT ENACTED AND ORDAINED by the Council of the Borough of West Reading, Berks County, Pennsylvania, and it is hereby ENACTED AND ORDAINED by the authority of the same as follows:

Section 1. Section 430-21, titled "Parking prohibited at all times;" of Article III, titled "Parking Regulations", of Chapter 430, titled "Vehicles and Traffic", of the Borough of West Reading Code of Ordinances hereby alters the following location:

North Seventh Avenue	Both East	Reading Avenue and northwardly thereof

Section 2. Section 430-24 "Time limit parking" of Article III titled "Parking Regulations", of Chapter 430 titled "Vehicles and Traffic", of the Borough of West Reading Code of Ordinances, to add the following designation:

Name of Street	Side	Time Limit	Hours	Days	Location
South Sixth Avenue	East and West	3 hours	10:00 a.m. to 8:00 p.m.	Monday through Saturday	Chestnut Street to Spruce Street

Section 3. Section 430-26 "Special purpose parking zones" of Article III titled "Parking Regulations", of Chapter 430 titled "Vehicles and Traffic", of the Borough of West Reading Code of Ordinances, to add and remove the following designations:

Name of Street	Side	Authorized Purpose	Days	Location
South Sixth Avenue	West	Patient loading and unloading	Monday through Friday 8:00 a.m. to 6:00 p.m.	Second and third spaces north of Spruce Street
South Sixth Avenue	West	Patient loading and unloading	Monday through Friday 8:00 a.m. to 6:00 p.m.	Fifth space south of Wayne Avenue
South Third Avenue	West	Handicapped person	Every day	First space south of Spruce Street

Section 4. All Ordinances or Parts of Ordinances conflicting with the provisions of this Ordinance are hereby repealed insofar as they are inconsistent with this Ordinance.

Section 5. This Ordinance shall become effective upon enactment.

Section 6. The Code of Ordinances of the Borough of West Reading, Berks County, Pennsylvania, as amended, shall be and remain unchanged and in full force and effect except as amended, supplemented, and modified by this Ordinance. This Ordinance shall become a part of the Code of Ordinances of the Borough of West Reading, Berks County, Pennsylvania, as amended, upon adoption.
